MAINTENANCE

BUYER agrees that he/she will not sell, transfer ownership or possession of the puppy or any of his/her progeny to any person or organization whose intent it is to resell (pet store), trade, give away the dog, use it in experiments, laboratory or otherwise, or use it as breeding stock for a puppy mill. If, for any reason BUYER is unable or unwilling to keep and care for the dog, BUYER agrees to return the dog to the possession of the SELLER and assumes the cost of shipping if necessary. If the SELLER agrees, the puppy may be given to an appropriate home; however the SELLER will have first chance to obtain the dog.
BUYER agrees SELLER will immediately REPOSSESS DOG UPON EVIDENCE OF NEGLECT AND/OR ABUSE AT NO EXPENSE TO THE SELLER.
If BUYER or BUYER's successor or assigns should violate the foregoing terms and conditions, BUYER agrees to pay SELLER as liquidated damages an amount equal to the original Purchase Price as well as any transportation costs to return the dog to the SELLER

72 HOUR HEALTH EXAM

The BUYER has 72 hours to have the dog examined by a licensed veterinarian at BUYER's expense. Proof of exam is to be sent to the SELLER within 7 days of exam or the health agreement is null and void. If any LIFE THREATENING health defects are detected, a written statement, which includes Dr.'s name, address and phone must accompany the return of the puppy. The return of the puppy and AKC papers will be at BUYERS expense. Then and only then will a puppy be exchanged for a puppy of equal value within a timely manner, or when a puppy of equal value is available. If BUYER is unwilling to release the puppy and AKC papers into SELLERS possession, NO REFUND OR REPLACEMENT PUPPY will be offered, nor will SELLER be a part of the recovery process. Any claims must be made within this time period and will be verified by SELLER's own veterinarian. Exclusions to this 72 hour health guarantee are Worms, Giardia, Coccidia or any curable non genetic conditions. SELLER will not be responsible for any vet costs and will ask BUYER to return the puppy promptly. At that time, it will be discussed as to whether a replacement puppy will be honored by SELLER or if said puppy recovers to the satisfaction of the BUYER.

TWO YEAR HEALTH GURANTEE (See page 3a for further discription -This does not apply to dachshund puppies)

At BUYERS expense, X-ray films of the dog's hips and elbows, showing proper positioning and meeting OFA standards, must be submitted to OFA for evaluation at 24 months of age. Puppy's microchip number must be recorded on the X-rays. If lameness occurs within the first 14 months due to Oseteochondrosis (OCD) or if in the OFA's evaluation, the dog shows evidence of hip dysplasia or elbow dysfunction, the SELLER will offer for sale an additional puppy at 1/2 of the original purchase price. ONE YEAR HEALTH GUARANTEE

This puppy is guaranteed to the original BUYER for (1) ONE year. SELLER states that at the time of sale and to the best of SELLERS knowledge, this puppy is free of any congenital birth defects and illness. This health warranty **DOES NOT** include kennel cough which much like a common cold. Kennel cough must run its course, recovery is expected and kennel cough is not life threatening. BUYER is aware that dogs are prone to heat stroke and will be responsible to provide an environment that is healthy for their puppy. BUYER has also researched, is knowledgeable of the following conditions and BUYER is aware they are **NOT COVERED** in the congenital hereditary health warranty: *Demodectic Mange, *Cherry eye, *Entropies, *Ectropion or "loose hips", *Luxating patella or "slipped stifles", and any teeth issues such as *(over bite-under bite-baby teeth not removing naturally and the like). *Skin allergies, *Giardia, *Coccidian, *Internal parasites, *Bacterial or Viral infections, *Elongated soft palette, *Umbilical hernia and *Nasal snares. Undescended testicles are not covered, Nor is inability to breed/sterility. Deafness and Blindness is occasionally seen in this breed. Common puppy problems that may occur due to the stress of adjusting to a new environment or mishandling by the new owner are not warranted under the limited health guarantee, including, but not limited to, coccidia, giardia, internal parasites, parvo, distemper, hypoglycemia. _____

The BUYER agrees to maintain the dog/puppy's health in good condition and to provide yearly examinations, proper vaccines, *heart worm test *(where applicable) and any other usual procedures necessary to assure good health and will stay in compliance of the spay/neuter agreement per this contract. _____

The SELLER has done everything possible to produce healthy, sound puppies through breeding dogs with the best records of being free of hip/elbow and back dysplasia. The SELLER has done the best of their ability to provide the best nutrition, veterinary care and facilities to ensure a healthy dog/puppy. The BUYER agrees to provide a suitable and safe area for this dog/puppy. _____

There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc. The BUYER assumes the responsibility to carry on with the appropriate vaccines, exercise and feeding schedule. Permanent ownership of this puppy is contingent upon BUYER'S compliance with this Agreement. All puppies must be spay or neutered by the age of 8 months old and proof of the spay/neuter must be received within fourteen (14) days after the surgery. In the event that the dog's health does not allow this agreement to be honored, SELLER must be provided with a statement from BUYERS veterinarian that this dog is not yet in physical or emotional condition for surgery. Based upon the veterinarian's evaluation of this dog the BUYER will contact the veterinarian and establish the earliest date that the procedure can be performed. The BUYER will notify SELLER of this amendment in writing (JM KENNELS/Jane Stamp 8029 CR 50, Johnstown CO 80534), at which time all other conditions of this agreement will apply and be enforced. It is the responsibility of the BUYER, not the veterinarian, to ensure that SELLER has received verification that the surgery has been performed. Failure to comply with this agreement by the date below, unless otherwise agreed to in writing and shall NOT exceed 12 months of age, will be considered a breach of this contract, and BUYER will pay to transport or will transport this dog back to SELLER and BUYER will not be entitled to a refund. If puppy/dog is not spay/neutered by date provided below, the BUYER will pay SELLER a penalty fee of \$5000.00 in addition to the original pet price. BUYER will include vet's proof of spay/neuter or invoice bill with the vet's state license number and his/her signature for verification by date listed below. Initials _____

BUYER, agrees to have this dog spay/neutered by no later than 8 months of age, on _____, 20____. BUYER understands that this spay/neuter agreement is an agreement that said puppy/dog will not produce a litter of puppies either as purposely bred or by accidental breeding. Accidental breeding is considered neglect and the dog/bitch will be returned to SELLER and all puppies born from any breeding, accidental or otherwise, will become the property of SELLER. BUYER also agrees that should the puppy/dog not be altered that BUYER will return said puppy back to SELLER at BUYERS expense with NO REFUND.

BUYER will be granted temporary custody of said puppy/dog until receipt of said puppy/dogs proof of spay/neuter from BUYERS veterinarian. BUYER will then be supplied with a letter of permanent transfer of ownership. Failure to provide to the SELLER the proof of spay/neuter of said puppy by 8 months of age, by _____, 20____, will nullify this agreement and the BUYER will deliver or pay to deliver the puppy and return it in good health to the SELLER and surrender puppy to SELLER without financial restitution or compensation of any kind. BUYER agrees that if the puppy/dog cannot be owned by the BUYER, for the lifetime of the puppy/dog, that BUYER will return the puppy/dog to the SELLER and SELLER will gladly take the puppy/dog back. In the case of the puppy's demise on or before the above listed date, a written statement from your veterinarian must be sent to SELLER, stating that the puppy has indeed passed away, and the cause of death. This is an unfortunate, but necessary, step.

In a perfect world we would like to have each puppy we place to stay in their original purchasing home. Things do happen, should BUYER be unable to fulfill this contract by the above agreed date, BUYER agrees to contact SELLER, in writing, phone or email and let us know BEFORE the puppy has been placed into a new home. If BUYER cannot keep puppy/dog, BUYER is not free to give the puppy away to another family member or anyone without receiving permission from SELLER first. SELLER requires this so we can keep track of all our puppies/dogs for their lifetime.

This contract is the BUYERS responsibility to enforce and comply. Should SELLER not receive conformation of the puppy/dog's spaying or neutering by the above listed date, as the original BUYER, BUYER will then be liable for the puppy/dogs full purchase breeding value, which can be up to three to five times higher than the original purchased pet value. In the event that a puppy/dog purchased from JM Kennels is suspected of being severely dysplastic two years after purchase, please take the following procedures:

- * Notify us by telephone, email or letter.
- * Submit an x-ray to the Orthopedic Foundation for Animals, University of Missouri - Columbia, MO 65210. Also send us a copy of the original x-rays of the severely dysplastic dog.
- * If the OFA finds the dog to be "Severely Dysplastic" then to qualify for a replacement puppy is as follows:
 - a.) The letter must state that the animal has not been overfed for its height/structure and has received regular check-ups and has been on a regular vaccination and worming program.
 - b.) The original registration papers for the dog must be sent back to us.
 - c.) The dog must have been x-rayed for this condition after its second birthday but before 2 years after purchase. Since the puppy is usually 8 weeks or older when purchased, this will give you an 8-week period to do the x-ray. (X-rays taken before the dog is 2 years of age may not portray true results during growth spurts)
 - d.) The dog must never be used for breeding, not be over weight, and must still be with its original owner.
 - e.) No replacement will be given if the dog has been over exercised during their growth period (until 2 years), which is running with or 'jumping' the dog excessively.

After these qualifications have been met, you may choose a replacement pup (of equal quality) from any litters, subject to availability, paying the difference in price if you desire a more expensive puppy (as our prices change occasionally). NO CASH REFUNDS are given. NO FURTHER or PREVIOUS guarantees are implied verbally, written or otherwise stated.

Rabies Prevention



What is Rabies?

Rabies is a deadly disease caused by a virus that attacks the nervous system. The virus is secreted in saliva and is usually transmitted to people and animals by a bite from an infected animal. Less commonly, rabies can be transmitted when saliva from a rabid animal comes into contact with an open cut on the skin, or the eyes, nose, or mouth of a person or animal. Once the outward signs of the disease appear, rabies is nearly always fatal.

Why should I be concerned?

Rabies is increasing in wildlife throughout Colorado, placing both humans and animals at risk for this deadly disease. Skunks and bats are the most significant sources of rabies in Colorado. Skunks, bats, raccoons, foxes and coyotes can carry rabies. In Colorado, other wild animals, dogs, cats, horses and livestock can become infected if they are bitten by a rabid animal. Contact with infected wild or domestic animals places you and your family at risk for rabies infection.

What are the signs of rabies in animals?

Once the rabies virus enters the body, it travels along the nerves to the brain. Dogs, cats, and ferrets with rabies may show a variety of signs, including fearfulness, aggression, excessive drooling, difficulty swallowing, staggering, and seizures. Rabid wild animals may only display unusual behavior; for example, an animal that is usually only seen at night may be wandering in the daytime.

What can I do to help control Rabies?

- * Have your veterinarian vaccinate your dogs, cats and ferrets. Your veterinarian will advise you on the recommendation frequency of vaccination in your area.
- * Reduce the possibility of exposure to rabies by not letting your pets roam free. Keep cats and ferrets indoors, and supervise dogs when they are outside.
- * Don't leave exposed garbage or pet food outside, as it may attract wild or stray animals.
- * Wild animals should never be kept as pets. Not only may this be illegal, but wild animals pose a potential rabies threat to caretakers and to others.
- * Observe all wild animals from a distance. A rabid wild animal may appear tame but don't go near it. Teach children NEVER to handle unfamiliar animals – even if they appear friendly.
- * If you see a wild animal acting strangely, report it to the city or county animal control department.

In addition to vaccinating your pets, horses and livestock, follow these precautions to prevent exposure to rabies:

- * Protect your home from wildlife. Close holes around the foundation of your house; cover window sills; screen chimneys and vents; and seal cracks and holes larger than 1/4 inch in diameter. Remove debris on your property that could provide nesting areas for wildlife.
- * Maintain control of your pets. Keep your cat indoors or attach a bell to its collar to discourage it from hunting.
- * Keep your dog under direct supervision. Do not allow your dog to run off-leash in parks or wilderness areas.
- * Spay or neuter your pets. This will reduce the number of unwanted or stray animals in your community.
